Operation, programming and maintenance of your landscape and/or irrigation components is your responsibility. Any inquiry, complaint or claim you wish to assert related to equipment performance, equipment defects or services provided to you, whether under the Program or by separate contract, must be presented directly to the equipment manufacturer/distributor and/or Program Installer or other installer.
