Re: Gift Disclosure

During the recent ACWA 2022 May Conference in Sacramento, we hosted a dinner on Tuesday, May 3, 2022, at The Firehouse Restaurant. As you know, the Political Reform Act and the Fair Political Practices Commission regulations require the disclosure of gifts of \$50.00 or more, and gifts cannot exceed \$520 annually.

Calculating the amount of the meal is difficult because each person in our group did not order the same thing and some food and drink was shared. We can say the table *averaged* \$163.26 per person. On this basis, your "gift" amounted to \$163.26.

We hope you enjoyed sharing the evening with us at il Corso Restaurant in Palm Desert. We are glad that you were able to join us.

Under the FPPC regulations for reporting gifts on Form 700, you may need to report the value of the hosted dinner which is your “pro-rata share” of the cost of the event. According to FPPC Regulations section 18946.2 for “invitation-only” events, such as our dinner a public official’s “pro rata share” of the cost of the event means: “the cost of the food, catering services, entertainment, and any item provided all attendees divided by the number of acceptances or the number of attendees.”

Based on this FPPC regulation, we have calculated the value of the dinner to be **\$103.09** per person. If a guest, including your spouse, accompanied you to the dinner, the value of his/her dinner is also attributable to you as a gift and is required to be reported on your Form 700, unless your guest is also a client of the firm.
